Unfinished business/updates:

- Kristen shared that New London Elementary School had a Penny War for Red Ribbon Week and donated their contributions of over \$1,900.00 to MHAS. Committee members signed a thank you card that will be sent to the school and discussed ideas on ways to allocate these funds to New London.
 - These funds should go back to the New London schools. Kristen will work with the administration to get ideas on what would benefit the school and the students the most.
- January Meeting
 - o Location: Huron County DJFS, Norwalk
 - o Presentations:
 - OhioGuidestone and Oriana House will be presenting at the Board meeting.
 - Open Board Seats
 - Program Chair (Motion)
 - Kristen shared that Ms. Erin Bohne has volunteered to become the Chair of the Program Committee.
 - Committee members had no further questions or concerns. They were in favor of appointing Ms. Bohne as Chair of the Program Committee.
 - Application for open seats
 - Kristen shared that in November committee members were in favor of sending Ms. Dayna Goodsite's application to the Huron County Commissioners for approval. She was interviewed and appointed by them in December. Kristen will reach out to her to see if she is available to take the Oath of Office at January's board meeting.
 - Kristen shared that a Huron County resident, Mr. Austin Shade, reached out asking if there were any open Board seats because he reads the Board minutes online and saw open board seats were recently discussed. He is from Bellevue and currently lives in Monroeville. He works for Sandusky County EMS. His reason

for wanting to join the Board is to give back to our community. Kristen shared that she thinks he would be a good fit for the open seat.

- Having someone trained in CIT and a part of the younger generation will be valuable.
- Because he has read the meeting minutes, he should have more orientation to what the board does than the typical person.
- Kristen stated that the two previously discussed potential candidates did not respond.
- Committee members had no further questions or concerns regarding open board seats. They were in favor of sending Austin Shade's application to the commissioners for approval.

• Levy Overview

- o Kristen shared that the Levy committee met last week. The levy is scheduled to go on the ballot in less than four months.
- Kristen shared that the Commissioners have not approved the levy to go on the ballot yet. They have questions about the need for an increased amount of levy funding. She is presenting to them at the Commissioners meeting on Thursday to inform the newly appointed commissioners about what the Board does and how the levy funds are utilized. She has sent the Levy report to them to review ahead of time.
 - Commissioner Brad Mesenburg is now the MHAS liaison.
- o A committee member suggested we should focus on individual successes.
 - There will be success stories included in the levy toolkit.
- o Kristen reviewed the volunteer fact sheet handout.
 - Have conversations about the levy, explaining what it entails and being transparent.
 - If anyone is approached with negative feedback do not engage, refer them to the board.
 - Peer-to-peer engagement is very important, use the talking points when having these discussions.
 - Stressing the importance of not only supporting the levy but also going out and voting for the levy.
 - Having volunteer involvement and attendance when presenting or having a town hall meeting in a community that they live in.
 - Board staff live within a 10-minute radius of the board office so getting volunteers in other communities is very important.
 - Share social media posts.
 - Identify five people to put levy signs in their yards.
 - If anyone has any additional suggestions or ideas, contact Kristen.
- o Committee members had no further questions or concerns.

• Annual Report (Motion)

- o Kristen shared that the annual report has been sent to board members via email. She asked if there were any questions, concerns, or comments. Once the board approves the annual report it will be sent to the State department, the Commissioners, and the Huron County Auditor per the Ohio Revised Code.
- Committee members had no further questions or comments. They were in favor of adding a motion to approve the Annual Report to the board agenda.

• SAR

 Kristen shared that OhioMHAS will be auditing the Huron County board in February, which is now called BAR (Board Assistance Review). This is a deep dive into the board's fiscal operations. The last week of February is blocked off for the audit. This will be the focus of the Board staff over the next month. OhioMHAS has not consistently audited Boards over the past 10 years. Kristen will keep board members posted on the progress.

o Committee members had no further questions or comments.

• TBD Solutions (Motion)

- o Kristen shared that the opportunity to apply for BSCA funding was announced in December with a deadline for submission before the next board meeting. She reached out to Ms. Lenora Minor, Board Chair, and Ms. Sandy Hovest, Finance Committee Chair, requesting approval to apply for this funding. They were in favor of her application.
- This is the second round of BSCA funding. The initial funding was used to build a Behavioral Health Disaster Preparedness plan. This funding amount is to be used to expand the plan and partner with the surrounding counties to ensure the plan format is similar and build a backup plan, incorporating resources from counties within Northwest Ohio. TBD Solutions will write this plan.
 - There are additional items that Huron County wanted to add to the plan, which is why the board is applying separately from the region. The addition includes CISM training and covering the law enforcement officers' time for CIT trainings.
 - Ms. Sandy Hovest suggested ensuring that what is in the appendix of the county plan is compatible with the main section.
- Committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.

Discussion Items:

- Recovery Housing Program Funding (Motion)
 - o Authorize Executive Director to submit application to OhioMHAS for Recovery Housing Program funding in the amount of \$38,880.00.
 - Kristen shared that this is the second year of these funds. They are used to cover rent for the individuals residing at the recovery homes and a small admin cost.
 - Mr. Ben Chaffee asked if there is a way to authorize Kristen to apply for any grants up to a specific dollar amount, then if the grant is awarded bring it to Board members. Perhaps passing an annual motion authorizing this process.
 - o Kristen will contact Mr. Randal Strickler for guidance on this suggestion and keep committee members posted.
 - o Kristen can approve up to \$50,000 for admin costs and crisis services.
 - Kristen shared this application is through Ohio Department of Development, not OhioMHAS. This will be updated on the board meeting agenda.
 - The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.
- Bipartisan Safer Communities Act Funding (Motion)
 - O Authorize Executive Director to submit application to OhioMHAS for Bipartisan Safer Communities Act funding in the amount of \$56,000.00.
 - Kristen shared this is the second round of these funds used to continue to update a Behavioral Health Disaster Preparedness plan.
 - The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.
- Landlord Incentive Funding (Motion)
 - o Authorize Executive Director to enter into a SFY 2025 contract addendum with Family Life Counseling in the amount of \$22,350.00 utilizing OhioMHAS Landlord Incentive Funding.
 - Kristen shared this is the second year of these funds. They are used to encourage landlords to rent to individuals who have had challenges with mental health issues and substance use. When the funds were initially announced Family Life Counseling was the

only agency that wanted to utilize the funding opportunity. They have identified two landlords who are willing work with them but have not been able to have any individuals able to utilize the funding.

- The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.
- Firelands SFY 2024 (Motion)
 - To approve a payment from SFY 2024 to Firelands Counseling and Recovery Services in the amount of \$1,331.32.
 - Kristen shared that as Firelands were reconciling their FY24 year-end they noticed a payment was missing. This was an error made by the Board's fiscal manager and should be paid. This invoice will come out of levy funds.
 - The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.
- Levy Reserves (Attachment I, Motion)
 - o Motion: To approve a minimum reserve fund balance of \$822,651.83 and a maximum reserve fund balance of \$2,467,955.50.
 - o Current levy reserve amount: \$1,245,195.69
 - Kristen reviewed the levy reserves policy which states the board's levy reserves amount should not be less than 3 months of the average monthly payments over the past three years and no more than 9 months of the average monthly payments; see Attachment I. The current levy reserve amount is within that range. The intent of this policy was to bring transparency and give the community an idea of where the levy reserves amount stand.
 - The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.
- Huron County Auditor Budget (Attachment II)
 - o Motion: To approve the Calendar Year 2025 Annual Budget as shown in Attachment II.
 - Cari reviewed the CY25 Annual Budget as seen in Attachment II, explaining the budget information came from the actual amounts that were spent in CY24. The revenues and expenditures are lower this year due to less SOR funding.
 - The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.
- November 2024 Financial Report & Statement of Activities (Attachment III, motion)

 - The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.

- December 2024 List of Bills (Attachment VI, motion)
 - The committee members had no further questions or concerns and were in favor of adding the motion to the board agenda.
- Cari reviewed November and December 2024 Financial Report & Statement of Activities, and November and December 2024 List of Bills with the committee members.
 - Committee members asked if it was necessary for them to review every report in this packet. They shared that it can be cumbersome.
 - Cari shared that she uses each of these reports to balance with the Auditor's office each month, but they are not all necessary for the committee members to review. The statement of activities shows the best glimpse of the fiscal year budget, including the monthly revenues and expenditures. The list of Revenues, Expenditures, Cash Balance, Encumbrances, and Ending Balance come from the Auditor's Office and should still be included. Kristen suggested that this information be added to the bottom of the Statement of Activities. Additionally, she shared that the List of Bills is required for the Board members to review.
 - Moving forward the Finance committee will review the Statement of Activities and List of Bills. Cari will also have a Finance Report explaining anything that is outside the norm.
- A Committee member asked if there was a way for the Board to know when Board funds are being spent on treatment if other insurance is available, and the treatment provider does not investigate the insurance.
 - All treatment claims are run through the GOSH system and outside of that there is no way to investigate each claim in more detail. Agencies do have annual fiscal audits and either CARF or Brown Consulting for programing audits.
- Kristen shared that Firelands is having issues with Medicaid not covering certain crisis codes. This may have an impact on the Board in future, she will keep the committee members posted.
- It was suggested that the Board have a blown-up map of the county and when volunteers ask for levy signs have it pinned on the map to ensure there are areas throughout the whole county with signs and not just one concentrated area.
